POSITION SUMMARY:

The Practice Development Consultant (PDC) for Child Welfare provides practice advice, in a wide range of serious and complex case situations. The (PDC) will serve several teams and will be asked to respond to the concerns/needs of social workers, Team Leaders, Managers. The (PDC) will respond with clinical consultation representing evidence-based practice guidance in each case situation. While responding to case specific consultation requests, the consultant will also support capacity building by assisting in the development and provision of training. The (PDC) provides support for programming and service delivery to facilitate best practice.

Reporting to the Director of Practice, PDC's engage in inquiry and analysis regarding all matters of child welfare including but not limited to critical incidents and fatalities of children in care to guardianship matters. PDC's provide support and oversight regarding current practices and propose innovative ideas and strategies in addressing the gaps and challenges to practice. PDC's further conduct clinical research to understand best practice trends in child welfare and recommend changes where it would benefit both stakeholders and the children/families being served.

EDUCATION AND EXPERIENCE:

- BSW or MSW; or BA in Child and Youth Care; or M.Ed Counselling/MA Clinical Psychology having completed a practicum in family and child welfare; OR
